**How We Will Calculate Your Balance:** We use a method called "average daily balance (including new purchases)." An explanation of this method is provided in your credit card agreement.

**Billing Rights:** Information on your rights to dispute transactions and how to exercise those rights is provided in your credit card agreement.

**Prime Rate:** The APR will vary based on changes in the Index, the Prime Rate (the base rate on corporate loans posted by at least 70% of the 10 largest U.S. banks) published in the *Wall Street Journal*. The Index will be adjusted on the 10<sup>th</sup> day of each month or the business day preceding the 10<sup>th</sup> day if that day falls on a weekend or holiday. Changes in the Index will take effect beginning with the first billing cycle in the month following a change in the Index. Increases or decreases in the Index will cause the APR and periodic rate to fluctuate, resulting in increased or decreased interest charges on the account. Prime Rate+12.00% is used to determine APR for purchases, balance transfers, and cash advances. As of December 11, 2025, the Index was 6.75%. The APR will be limited to a floor rate of 12.00% and a ceiling rate of 21.00%.

<sup>1</sup>*Monthly Periodic Rate: The monthly periodic rate used to calculate interest for your account is 1.56250% which is calculated by dividing the APR by 12.*
